Big Trees on the Move Again

In early June, Maritime Landscape Services crossed the New Brunswick border again with its large Vermeer TS 84 Truck-mounted Tree Spade for an emergency transplanting project at the University of New Brunswick campus in Fredericton. Due to major infrastructure work for a new Athletic Field House, 8 trees ranging from 7 inch to 4-inch caliper had to be moved in full leaf to new locations close by

Arborists often debate the practice of transplanting larger trees because of establishment problems. The After-Care Program is key as evidenced by two 7-8 inch Lindens & 6 inch Norway Maple that are prospering and taking off well as of June 2010 after being moved to KenWo Golf course in the Annapolis valley in the spring of 2008 by a large Truck Tree spade.
